ORDINANCE NO. 287

AN ORDINANCE OF THE TOWNSHIP OF OHIO, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, APPROVING THE TERMS AND CONDITIONS OF POLICE PROTECTION AGREEMENTS WITH THE FOLLOWING COMMUNITIES, AND AUTHORIZING THE EXECUTION OF SAID AGREEMENTS.

WHEREAS, the Township of Ohio and the communities set forth herein, namely the Borough of Emsworth, the Borough of Sewickley Hills, the Borough of Ben Avon, the Township of Neville, the Township of Aleppo, the Township of Kilbuck, and the Borough of Ben Avon Heights, having determined over a period of time that the provision of police protection services by the Township of Ohio, through the Ohio Township Police Department, to said municipalities, is in the mutual interest of the municipalities, and will preserve the health, safety and welfare of all of the communities subject to said police agreements; and

WHEREAS, the Township of Ohio and the various communities set forth herein have entered into police protection agreements setting forth the terms and conditions of the provision of police services by the Township of Ohio, through the Ohio Township Police Department, to said named communities; and

WHEREAS, cooperation between the Township of Ohio and the various communities in the exercise and performance of their governmental powers, duties and functions is authorized by the various Acts of the General Assembly, including but not limited to the Borough Code, the Second Class Township Code, and the Intergovernmental Cooperation Act; and

WHEREAS, the Intergovernmental Cooperation Act, separate and apart from these other Codes, provides for an ordinance related thereto. Recognizing that these Agreements are also authorized by the Borough Code and the Second Class Township Code by other various laws, not requiring an ordinance, the purpose of this ordinance is to conform to the requirements of the Intergovernmental Cooperation Act.

NOW, THEREFORE, be it Ordained and Enacted by the Board of Supervisors of the Township of Ohio, Allegheny County, Commonwealth of Pennsylvania, and it is hereby Ordained and Enacted by the authority of the same as follows:


1. Pursuant to the Intergovernmental Cooperation Act, 53 Pa. C.S.A. Section 2301, et seq., the terms and conditions of the various police agreements by and between the Township of Ohio and the following communities, the Borough of Emsworth, the Borough of Sewickley Hills, the Borough of Ben Avon, the Township of Neville, the Township of Aleppo, the Township of Kilbuck, and the Borough of Ben Avon Heights, are hereby approved and adopted. Further, the Township is authorized to enter into any extension of said Agreements beyond the current terms set forth in said executed Agreements.

2. The appropriate authorized officers of the Township of Ohio are hereby authorized to execute and enter into said police protection agreement on behalf of the Township of Ohio.
