

TOWNSHIP OF OHIO
ORDINANCE NO. 224

AN ORDINANCE OF THE TOWNSHIP OF OHIO, COUNTY OF ALLEGHENY, AND THE COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 66 OF THE CODE OF THE TOWNSHIP OF OHIO REGARDING CERTAIN PERMIT FEES, APPLICATION FEES AND COSTS.

NOW, THEREFORE, BE IT ENACTED and ORDAINED by the Township of Ohio, Allegheny County, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

That Chapter 66, Code of the Township of Ohio, be amended as follows:

Section 66-1, paragraph A, to provide for an application fee of Five Hundred Dollars (\$500.00), plus Twenty Five Dollars (\$25.00) per acre or portion thereof, plus any technical costs incurred by the Township.

Section 66-1, paragraph C, to provide for a Three Hundred and Fifty Dollars (\$350.00) application fee, plus any technical costs incurred by the Township.

Section 66-1, paragraph E, to provide for a fee of Five Hundred Dollars (\$500.00) plus Twenty Five Dollars (\$25.00) per acre or fraction thereof, plus any technical costs incurred by the Township. Said paragraph shall also include language to provide for fees for a 2-lot subdivision of Three Hundred Fifty Dollars

(\$350.00) plus any additional technical costs incurred by the Township; 3 or more lot subdivision fees of Five Hundred Dollars (\$500.00) plus Ten Dollars (\$10.00) per lot and any technical costs incurred by the Township for residential subdivisions and Five Hundred Dollars (\$500.00) plus Twenty Five Dollars (\$25.00) per acre or any fraction thereof plus any technical costs incurred by the Township for non residential subdivisions of 3 or more lots.

Section 66-1, paragraph P, (to be relettered as paragraph M) shall be amended to provide the per day fee of Fifteen Dollars (\$15.00); per week fee of Sixty Dollars (\$60.00); per month fee of Two Hundred Dollars (\$200.00); and annual fee of Five Hundred Dollars (\$500.00).

Section 66-1 paragraphs L, M, and N are hereby deleted, and paragraphs O through S are relettered as paragraphs L, M, N, O, and P, respectively.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of the Township of Ohio on this 10 day of November, 1997.
