REGULAR MEETING  
November 1, 2021**

**CALLING THE MEETING TO ORDER** – The regular monthly meeting of the Ohio Township Board of Supervisors was called to order by Chairman, Tom Beatty, on Monday, November 1, 2021 at the Ohio Township Municipal Building. It needs to be noted that due to the Covid-19 pandemic, the Supervisors attended the meeting via conference call along with Township Solicitor Michael Witherel. Although the meeting was open to citizens, no citizens were in attendance.

The meeting was opened with the Pledge of Allegiance.

Mr. Beatty asked the secretary to note the presence of supervisors, Tom Beatty, Herb Hartle and Jim Reid. It is noted that Township Manager John Sullivan and Township Clerk Patricia Cannon were in attendance at the municipal building.

**COMMENTS FROM THE CITIZENS** – None.

**APPROVAL OF THE MINUTES** – Mr. Beatty announced that the minutes were posted on the bulletin board. Mr. Reid made a motion, seconded by Mr. Hartle, to approve the minutes as posted. The motion was carried unanimously.

**TREASURER’S REPORT** – Mr. Sullivan read the treasurer’s report for the month of October. Mr. Hartle made a motion, seconded by Mr. Reid, to approve the treasurer’s report as read. The motion was carried unanimously.

**INVOICES DUE FOR PAYMENT** – Mr. Sullivan read the total invoices due for payment are \$306,149.90 which covers checks #31703 to #31845 (PNC Bank). Mr. Hartle made a motion, seconded by Mr. Reid approving the invoices due for payment. The motion was carried unanimously.

**NEW BUSINESS** – Mr. Beatty stated we have Resolution No. 17-21 for consideration. This is a resolution appointing Michael Basista, 188 Freedom Lane, Sewickley Ridge, to the Ohio Township Sanitary Authority to fill the remainder of Rob Trombold terms which expires December, 2025. **Mr. Hartle made a motion, seconded by Mr. Reid to approve Resolution No. 17-21. The motion was carried unanimously.**

We have Resolution No. 18-21 for consideration. This is a resolution authorizing an application to the PA Municipal Assistance Program for the joint comprehensive plan between Ohio Township and Franklin Park. **Mr. Reid made a motion, seconded by Mr. Hartle to approve Resolution No. 18-21. The motion was carried unanimously.**

We have Resolution No. 19-21 for consideration. This is a concurring resolution for a grant application through the RAAC (Redevelopment Authority of Allegheny County) in the amount of \$500,000 for park renovations. **Mr. Hartle made a motion, seconded by Mr. Reid to approve Resolution No. 19-21. The motion was carried unanimously.**

We have Resolution No. 20-21 for consideration. This is a concurring resolution for an additional grant application through the RAAC in the amount of \$205,300 for pollutant reduction plan implementation. **Mr. Reid made a motion, seconded by Mr. Hartle to approve Resolution No. 20-21. The motion was carried unanimously.**

We have pay request #1 from Jet Jack for work on the 2021 Stormwater Improvements in the amount of \$88,605 for consideration. **Mr. Hartle made a motion, seconded by Mr. Reid to approve Pay Request #1 from Jet Jack. The motion was carried unanimously.**

We have the Sewickley Hills Police Service Contract for consideration. **Mr. Reid made a motion, seconded by Mr. Hartle to approve the Sewickley Hills Police Service Contract. The motion was carried unanimously.**

**SOLICITORS REPORT** – none.

**CORRESPONDENCE** – none.

**ADJOURNMENT** – There being no further business, Mr. Reid made a motion, seconded by Mr. Hartle to adjourn the meeting. The motion was carried unanimously.
