ORDINANCE NO. 119

AN ORDINANCE OF THE TOWNSHIP OF OHIO, COUNTY OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA GRANTING A NON-EXCLUSIVE FRANCHISE TO CENTRE VIDEO CORPORATION, ITS SUCCESSORS AND ASSIGNS, TO CONSTRUCT, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM IN THE TOWNSHIP OF OHIO, COUNTY OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA, AUTHORIZING THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF OHIO TO ENTER INTO AN AGREEMENT SETTING FORTH WITH SPECIFICITY THE TERMS AND CONDITIONS OF SAID NON-EXCLUSIVE FRANCHISE AND THE OPERATION THEREOF AND SETTING FORTH CONDITIONS ACCOMPANYING THE GRANT OF FRANCHISE PROVIDING FOR TOWNSHIP REGULATIONS AND USE OF THE CABLE TELEVISION SYSTEM.

WHEREAS, the Township of Ohio is empowered by the laws of the Commonwealth of Pennsylvania to grant non-exclusive franchise cable television systems within the limits of said Township; and

WHEREAS, Centre Video Corporation, has indicated an intent and desire to erect, construct and operate a non-exclusive cable television system in the Township of Ohio; and

WHEREAS, the Supervisors of the Township of Ohio feel that it is in the public interest to provide such services to the residents of the Township of Ohio.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, by the Board of Supervisors of the Township of Ohio, and it is hereby ordained and enacted by authority of same as follows:

SECTION I. That the Township of Ohio does hereby grant to Centre Video Corporation, its successors and assigns, a non-exclusive franchise for a period of fifteen (15) years from the effective date of this non-exclusive franchise, which franchise may be renewed for an additional fifteen (15) year period following a full public proceeding affording due process, to operate, construct and maintain a cable television system in the Township of Ohio.

SECTION II. That the said grant of authority to Centre Video Corporation is of a non-exclusive nature.

SECTION III. That the Board of Supervisors of the Township of Ohio is hereby authorized to enter into an agreement setting forth the terms and conditions of said franchise and the terms under which said franchise shall be operated.

SECTION IV. That the effective date of this Ordinance shall be the date upon which a final agreement is finalized between the Township of Ohio and Centre Video Corporation, which agreement will be attached hereto and made a part hereof.

SECTION V. In the event no agreement is executed within sixty (60) days from the adoption, the franchise herein granted is of no force and effect.
