

TOWNSHIP OF OHIO

ORDINANCE NO. 144

AN ORDINANCE OF THE TOWNSHIP OF OHIO, ALLEGHENY COUNTY, PENNSYLVANIA CHARGING AND ASSESSING THE COST AND EXPENSE OF THE INSTALLATION OF WATER LINES IN THE RIDGE ROAD WATER DISTRICT ON THE OWNERS OF PROPERTIES ABUTTING THE SAID WATER LINES BY AN EQUAL ASSESSMENT ACCORDING TO THE FRONT FOOT; DIRECTING THE COLLECTION OF THE SAID ASSESSMENTS; AND PROVIDING FOR THE FILING OF MUNICIPAL CLAIMS.

WHEREAS, the then Board of Supervisors of the then Township of Ohio, Allegheny County, Pennsylvania, pursuant to the provisions of Ordinance No. 140 of the said Township, caused water lines to be installed in the Ridge Road Water District; and

WHEREAS, Ordinance No. 140 provides that the cost and expense of the installation of the said water lines shall be charged and assessed on the owners of properties abutting the said lines and benefited and accomodated by the lines; and

WHEREAS, the now Board of Supervisors of the Township of Ohio has determined that it will make the said assessment according to a front foot rule and has caused to be prepared a schedule showing the owners of abutting properties, which indicates an assessment of per front foot against the said properties;

NOW, THEREFORE, IT IS HEREBY ORDAINED AND ENACTED by the Board of Supervisors of the Township of Ohio as follows:

Section 1. The cost and expense to the Township of Ohio of installing water lines in the Ridge Road Water District in the total amount of \$21,803.51 is hereby assessed against the property owners abutting the said lines in the amount of front foot:

Section 2. The manager of the Township of Ohio is hereby directed to give written notice to the above property owners that the assessments herein made are due and payable on or before May 29, 1987. Notice shall be given by mail to the property owners, or, in the case of a non-resident owner, by posting the premises or leaving a copy thereof with the occupant, if any, and mailing the notice to all owners residing elsewhere whose addresses are known.

Section 3. Any assessments remaining unpaid on May 29, 1987 shall be turned over to the Township Solicitor who shall file a municipal claim as provided by law. In case municipal claims must be filed, a penalty of 5% and interest at the rate of 6% per annum from May 29, 1987 shall be made a part of the claim.
