ORDINANCE NO. 45

AN ORDINANCE AMENDING ORDINANCE NO. 17 IMPOSING A TAX FOR GENERAL REVENUE PURPOSES ON ALL AUTOMOBILE TRAILERS SITUATED IN THE TOWNSHIP OF OHIO AND PROVIDING PENALTIES FOR NON-PAYMENT.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Ohio Township, pursuant to and under the authority of the Act of General Assembly of Pennsylvania, approved June 25, 1947, P.L. 1145, as amended, and it is hereby ordained and enacted by and with the authority of the same that Ordinance No. 17 enacted December 1, 1954 is hereby amended to read in its entirety as follows:

"Be it ordained and enacted by the Board of Supervisors of Ohio Township, pursuant to the Act of General Assembly of Pennsylvania, approved June 25, 1947, P.L. 1145, as amended, and it is hereby ordained and enacted by and with the authority of the same:

Section 1. There is hereby imposed for general revenue purposes, a tax of \$3.00 per month, on the use or occupancy of house trailers suitable for living quarters, whether or not occupied, situated in Ohio Township, unless exempted or excluded from said tax as hereinafter provided.

Section 2. Said tax shall be levied against the registered owner of the trailer or against that person in whose name the trailer is licensed. If, in fact, the trailer is occupied or owned by a person other than the registered owner, that person or those persons shall be subject to said tax.

Section 3. Said tax shall be due and payable in advance on the first day of each and every calendar month commencing with the calendar month beginning next after the expiration of the first thirty (30) days said trailer is situated in Ohio Township, and shall be payable at the office of the Township Treasurer. After the 10th day of the month, any unpaid tax shall be delinquent and a penalty of five (5%) per cent shall be added thereto.

Section 4. Said tax shall be levied against any trailer which is legally used as a residence or usable therefore, whether or not the said trailer is in a mobile condition, provided, however, that any trailer which has been determined to be subject to assessment for real estate taxes and has been so assessed shall not be subject to the tax hereby imposed for any year in which it is so assessed for real estate taxes.

Section 5. The owner or lessee of the real estate upon which any trailer subject to the tax hereby imposed is located shall be liable for the payment of said tax and penalty, if any, if the owner or occupant of said trailer fails to pay said tax.

Section 6. The Township Treasurer is hereby authorized to bring suit in Assumpsit in the name of the Township, against any person liable for the tax hereby imposed before any Justice of the Peace of the Township, at any time after said tax becomes delinquent.

Section 7. No part of this Ordinance shall be construed as permitting the use of trailers which are by other Ordinances illegally within Ohio Township.

Section 8. Any portion of this Ordinance which shall be construed as void or unconstitutional shall not affect the entire Ordinance or any other portion thereof.

Ordained and enacted into a law this 16 day of November, 1960.
