

TOWNSHIP OF OHIO

ORDINANCE NO. 68

AN ORDINANCE RE-ENACTING ORDINANCE NO. 17 AS AMENDED BY ORDINANCE NO. 45, IMPOSING A TAX ON ALL AUTOMOBILE TRAILERS IN OHIO TOWNSHIP; ORDINANCE NO. 18 IMPOSING A PER CAPITA TAX ON ALL ADULT RESIDENTS OF OHIO TOWNSHIP; ORDINANCE NO. 19 IMPOSING A TAX ON ADMISSIONS TO AMUSEMENTS IN OHIO TOWNSHIP; ORDINANCE NO. 21 IMPOSING A TAX ON THE PRIVILEGE OF TRANSFERRING REAL ESTATE SITUATE IN OHIO TOWNSHIP; ORDINANCE NO. 32 IMPOSING A TAX ON CERTAIN COIN OPERATED MACHINES OR DEVICES, AND ORDINANCE NO. 46 KNOWN BY THE SHORT TITLE OF OHIO TOWNSHIP EARNED INCOME TAX ORDINANCE FOR THE CALENDAR YEAR 1966.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Ohio Township, Allegheny County, Pennsylvania, pursuant to the authority granted by the Act of General Assembly of Pennsylvania, approved June 25, 1947, P. L. 1145, as amended, and it is hereby ordained and enacted by and with the authority of the same:

Section 1. The following tax ordinances are hereby re-enacted in their entirety and the same taxes imposed at the same rates for the calendar year beginning January 1, 1966 and ending December 31, 1966 upon exactly the same terms, provisions and conditions as provided in said ordinances as though the same were set forth at length herein:

- (a) Ordinance No. 17 as amended by Ordinance No. 45 entitled: "AN ORDINANCE ESTABLISHING, FOR GENERAL TAX PURPOSES, A TAX ON ALL AUTOMOBILE TRAILERS SITUATED IN THE TOWNSHIP OF OHIO, AND PROVIDING PENALTIES FOR NON-PAYMENT."
- (b) Ordinance No. 18 entitled: "AN ORDINANCE ESTABLISHING, FOR GENERAL TAX PURPOSES, A PER CAPITA TAX ON ALL ADULT RESIDENTS OF OHIO TOWNSHIP, STATING WHO SHALL BE SUBJECT TO THE TAX, THE AMOUNT OF THE TAX, WHEN IT SHALL BE PAID AND THE PENALTIES THEREFOR."
- (c) Ordinance No. 19 entitled: "AN ORDINANCE PROVIDING FOR THE LEVYING AND COLLECTION OF A TAX FOR GENERAL TOWNSHIP PURPOSES ON ADMISSIONS TO AMUSEMENTS WITHIN THE TOWNSHIP OF OHIO, REQUIRING ALL PERSONS, PARTIES, ASSOCIATIONS AND CORPORATIONS CONDUCTING PLACES OF AMUSEMENT TO SECURE PERMITS, IMPOSING DUTIES AND CONFERRING POWER UPON THE TOWNSHIP TREASURER OR OTHER AUTHORIZED AGENT, PRESCRIBING THE METHOD AND MANNER OF COLLECTING THE TAX IMPOSED BY THIS ORDINANCE AND IMPOSING PENALTIES FOR VIOLATION THEREFOR."

(d) Ordinance No. 21 entitled: "AN ORDINANCE OF THE TOWNSHIP OF OHIO, COUNTY OF ALLEGHENY AND COMMONWEALTH OF PENNSYLVANIA, IMPOSING A TAX FOR GENERAL REVENUE PURPOSES ON THE PRIVILEGE OF TRANSFERRING REAL PROPERTY, SITUATE WITHIN THE TOWNSHIP OF OHIO, PRESCRIBING AND REGULATING THE METHOD OF EVIDENCING THE PAYMENT OF SUCH TAX: CONFERRING POWERS AND IMPOSING DUTIES UPON CERTAIN PERSONS AND THE TOWNSHIP TREASURER AND SOLICITOR; AND PROVIDING PENALTIES."

(e) Ordinance No. 32 entitled: "AN ORDINANCE PROVIDING FOR THE LEVYING AND COLLECTION OF A TAX FOR GENERAL TOWNSHIP PURPOSES UNDER THE AUTHORITY OF THE ACT OF JUNE 25, 1947, (P.L. 1145) AND ITS AMENDMENTS, UPON THE PRIVILEGE OF USING FOR PROFIT WITHIN THE TOWNSHIP OF OHIO CERTAIN MACHINES OR DEVICES FOR AMUSEMENT, ENTERTAINMENT AND THE RENDITION OF MUSIC, WHICH ARE OPERATED BY THE INSERTION OF A COIN, SLUG, DISC, TOKEN, PLATE OR KEY; PROVIDING FOR THE COLLECTION OF SUCH TAX AND PRESCRIBING PENALTIES."

(f) Ordinance No. 46 known by the short title "THE OHIO TOWNSHIP EARNED INCOME TAX ORDINANCE."
